Insider Trading Window

Clause 7.7 of the Insider Trading Policy, 2009 as reviewed in July 2014 provides that;

"As a general rule, material information shall not be public the date that insiders become aware of it until at least one business day after it has been released by the Bank to the public. Insiders shall be allowed to trade for a period of three weeks from three (3) trading days after the disclosure of quarterly and annual financial results and any other material information".

The dates for the Insider Trading Window derived from the Bank's Financial Calendar for year 2015 are shown below.
